## RESIDENTIAL USE LIMITATIONS AND SHORT TERM RENTALS

Melody Ranch HOA and Teton County do not allow for short-term rentals less than 30 days in Melody Ranch. Both county regulations & our CC&R's prohibit this type of use. Violators will be fined by the HOA on their first violation and Teton County officials will be notified. Please be sure to remove your listings from any short-term rental websites (vbro.com, etc.) and refrain from this activity.

## PRIVATE PROPERTY
