Storage Parking Rules & Regulations

- 1. No more than two storage parking spaces per lot owner subject to the following: should all spaces become occupied and a homeowner without any space requests one the last homeowner to receive 2 spaces must relinquish one of the spaces, and so on, as necessary to provide storage spaces to a requesting homeowner who does not have one.
- 2. The item stored must be currently licensed, registered, and insured in the name of the homeowner(s). Copies of these documents must be provided to our office along with a **photograph** of the item before occupying the space.
- 3. Homeowner(s) will be assigned a space upon receipt of the above mentioned documents. Homeowners may only occupy the space assigned to them! If a homeowners wishes to change spaces or have a space preference, please let us know.
- 4. We will assign spaces on a first come, first serve basis starting at \$12 per month for the small spaces and \$24 per month for the longer spaces.
- 5. No other items including, but not limited to bikes, building supplies or lawn equipment will be permitted to be stored in the space.
- 6. Recreational vehicles must fit within the designated boundaries of your assigned space. Melody Ranch HOA does not insure any property that is stored. It is the sole responsibility of the homeowner to insure any and all items stored in our storage lot.
- 7. All storage holders must pay storage fees in a timely manner or rights to the facility may be revoked at the discretion of the Melody Ranch HOA Board of Directors and the Management Company.
- 8. If you sell your lot in Melody Ranch you must vacate your storage space by the scheduled closing on your lot. If you do not vacate, the Management Company has the right to remove your items from the space.
- 9. Sub-leasing storage spaces is prohibited.
- 10. Melody Ranch HOA reserves the right to tow items not registered or in the wrong location.
