SHOVELING REMINDERS

Neighbors, please remember that it is against state law to shovel the snow from your driveway into the roadway. It creates a hazard for cars and pedestrians when extra snow is moved into the road. Please remember to push or blow your snow into your yard or onto your banks and refrain from shoveling into the street or in the open space. Thank you for your cooperation!

ISD UPDATE

The Melody Ranch Improvement and Service District (ISD) wanted to take a moment to thank those of you who have repaired the leaking water service lines identified on your property. To date, those repairs are saving Melody Ranch about 50 gallons of water per minute (72,000 gallons per day) which was previously leaking from our water system. The ISD continues to address the water system operation, repair, and future planning needs. The ISD is currently having every water service curb stop tested, exercised and necessary repairs completed. Next spring, every water main valve and fire hydrant will be exercised to ensure these system components remain in good working order. The ISD Board has submitted a funding request to the Wyoming Water Development Commission (WWDC) for evaluating the Melody Ranch water system. Our funding application has advanced through initial approvals and is expected to be included in the WWDC's annual project funding request to the Wyoming Legislature, in early 2016. The WWDC intends to provide a \$180,000 Melody Ranch Level 1 engineering feasibility study that will likely include a complete system leak test, evaluate needs for a third well, pumping system upgrades, electrical control and telemetry system upgrades, water storage needs and more. The Level 1study costs are paid through the WWDC assistance program. Once the Level I study is completed, the Melody Ranch ISD Board will be able to apply for WWDC grant and loan assistance to fund the design and construction of recommended upgrades that are identified and prioritized through the study, most likely in the fall of 2017.

CHRISTMAS TREE PICK UP SCHEDULE

Melody Ranch will once again be offering Christmas tree pick up on Tuesdays and Thursdays following Christmas. If you would like to dispose of your tree, please leave it at the curb on December 29 and 31, January 5, 7, or 12. Please note, that after January 12th, this service will no longer be available and you will be responsible for disposing of your own tree. Be sure to have all of your lights, ornaments and tinsel completely removed from your tree prior to disposal. Thank you!

You may recall that last year the ski track was expanded to provide skiers with a full loop! Please enjoy it as well as the sledding hill this winter. COVENANT CORNER

~ Front porches are not to be used for storage. Patio/deck furniture is allowed in season however ladders, canoes, firewood, old appliances, etc. are not to be stored on porches. Please note that futons do not fall under the category of patio furniture and should not be placed on porches at any time. Grills are to be placed on back porches, with the exception of a home not having a back porch. This is a Tier One, \$25 fine. ~ Dogs are to be restrained or leashed within the community at all times. This includes while walking, running and bicycling on all roads and common areas within the community. First Violation is \$250 fine.

~ Vehicle Parking. All vehicles shall be parked in designated parking spaces on the lot or the spaces provided therefore on multiple dwelling lots. No more than two vehicles may be parked in driveways for extended periods of time. No vehicle may be parked on any street within Melody Ranch or on any yard or common area on individual or multiple dwelling unit lots. This would be considered a Tier Two, \$100 fine.
