UPDATE - MELODY PARK MEETING RESULTS

Thanks to everyone who was able to come to the meeting Thursday, January 13th, and/or send in comments – we had a great result, in that the joint Town/County Parks & Recreation board **voted unanimously to support the draft plan** for the neighborhood park in Melody, AND to recommend that it **be included in the FY '11-'12 budget** (to be developed this spring) by the County Commission.

Note: check the HOA website "Neighborhood Park" tab for all board correspondence, design, and staff meeting reports.

One unfortunate note – it became apparent at the meeting that there may be some problems in Parks & Recreation being able to actually begin construction this summer, even for the first phase. It may be that design, approvals, and planning would begin this year (new budget begins in July '11), with construction slated for spring, 2012.

The Melody Ranch HOA board has requested a meeting with County representatives to see what we can do to **get construction to begin this summer**. We will update you as we learn more, and may need direct comment to the Commissioners again.

It wouldn't hurt to email the Commissioners and Steve Ashworth – Parks director, asking them to do what they can to have construction begin this year, but if you'd rather wait until we have more information, that is appropriate too.

COVENANT CORNER

From the Rules & Regulations

- ❖ Firewood is to be stored behind a fenced enclosure or "out of sight" from the road and neighboring properties view at all times. Please see Article 5 - 5.6 in the CC&R's.
- ❖ Front porches are not to be used for storage. Patio/deck furniture is allowed in season however ladders, canoes, firewood, old appliances, etc. are not to be stored on porches. Please note that futons do not fall under the category of patio furniture and should not be placed on porches at any time. Grills are to be placed on back porches.

DOG OWNERS - PLEASE READ

Please be considerate of your neighbors. It is against the rules and regulations to allow your dog to roam free in Melody Ranch. All dogs must be leashed or restrained at all times. Not all homeowner's have dogs and don't care to have to pick up after their neighbors dog. If you live next to a vacant lot, this is not your property for your dog to relieve themselves. Please keep your dog from barking. If there is a roaming or barking dog that is a nuisance to you, please contact the animal control center at 733-2331 (Sheriff Office).

A FRIENDLY NEW YEAR REMINDER

Dogs and Cats in Teton County Wyoming are required to be licensed every year. The animals must be current on its rabies vaccination. The cost is \$1 if your pet is fixed, \$5 if it is intact. For all questions, please contact the Shelter at 733-2139 or animalshelter@ci.jackson.wy.us
