- Executive Session The board entered executive session at 8:46 and adjourned at 9:13
- Approval of November 21, 2017 Minutes Jonathan moved to approve the past meeting minutes. Flo seconded the motion. All voted in favor.

4) Report of Officer

- a) Secretary Treasurer
 - i) Delinquent HOA Dues Report

With no payment made in nearly a year the board will move forward on foreclosure process for the most delinquent owner. GTPM will send an email to him advising this will be the course unless he rectifies his delinquency by January 2, 2018. GTPM is working with the mortgage holder and Habitat for Humanity on any late accounts as they will intervene as soon as a payment is missed by owners of Habitat homes. Currently only one of those owners in on the delinquent list.

ii) Financial Review

Demerie reviewed the financial report. There is currently \$49,745 in the operating account and an additional \$174,569 in the maintenance reserve account. \$239,567 has been collected as income this year to date and \$243,775 has been spent on expenses. That amount includes the \$13,680 on the new mail boxes that the post office requested Melody purchase.

5) GTPM

There was nothing to report at this time.

6) Violations - Violation Log

Carrie reviewed the delinquent report with the board. Tina and Demerie discussed the procedure of violations with the board highlighting that each violation was handled exactly the same. The process of recording each and every violation and assessing letters and fines is consistent each time with each owner.

7) Old Business

b) Fence Repairs

d) Sunset Letter to Townhomes

Jonathan and Demerie have been crafting a response to the owners of the Townhomes responding to their concerns addressed in a letter from the fall. This response is based on the recommendations from the HOA legal counsel as approved by the board at last month's meeting. This response letter will be sent out later today.

8) New Business

a) Board Seats Availability

There are several homeowners that would be strong representatives on the board. These people will be approached in the coming weeks and invited to the next meeting if they are interested in serving.

b) DRC Openings

The DRC members have resigned from the committee. There were several people discussed as possible replacements and having a DRC comprised of paid professionals was also discussed. We will reach out to these individuals and see if there is any interest in being on the Design Review Committee.

- c) Flo indicated that there have been several homeowners that have discussed their interest in marking and lighting the entrances to Melody Ranch. The board would like to work with the ISD on this in 2018 and try to get something in place at each entry.
- d) There was additional discussion about the poor mail service that homeowners are receiving in Melody Ranch. Tina has spoken to the postmaster and was advised that there is an employee shortage in the local post office which is causing delays in mail delivery. There are also issues with the contractor hired by the USPS who delivers the mail. This is not only a Melody Ranch problem as other HOA's are having similar problems as well.
