#### 1) Homeowners & Guest Time

Jason Leslie attended the meeting to discuss his plans to build a greenhouse behind his home. Jonathan reviewed the plans and the DRC comments in regard to the requirement that this accessory structure be of similar character to the house. The plan is for the roof pitch to be the same as the new home and for the bottom 4' of the greenhouse to match the house siding. The greenhouse will be within the setbacks and will be linked with a gravel path to the house. He will have working drawings drawn up by a structural engineer for final approval. Flo moved to approve the preliminary design with the gravel path. Jonathan seconded the motion and all voted in favor.

Additionally, Jason expressed concerns that the construction dumpster he has on site is being "poached" and people are throwing away other debris in it including items in the "wood only" dumpster that are not wood. There are additional dump fees for him as a result and he would like the homeowners to be made aware of this and asked that a notice be sent out to them.

### 2) Executive Session

The board entered an executive session at 9:16 and adjourned at 9:39

3) Approval of September 18, 2018 board minutes

Matt moved to approve the minutes as edited. Flo seconded the motion. All voted in favor.

### 4) ARC/LRC

- a) Coles, 1-61, 1184 Melody Creek Lane, Garage Door
  The DRC reviewed these plans in light of the design guidelines for that lot and recommended approval. Jonathan moved to approve the new door. Todd seconded the motion. All voted in favor.
- b) Lofgren/Leslie, 1-206, Preliminary Greenhouse review and Landscape Approval
  See above for the greenhouse discussion and vote to approve the preliminary plans. The Landscape
  review committee approved the landscape plan as presented to them with the additional shrubs being
  moved near the gas fire pit. Jonathan moved to approve the landscape plans. Flo seconded the
  motion and all voted in favor.

c) Ryan, 2-30, 4345 Melody Ranch Dr., Landscape Approval

The landscape review committee reviewed the property and recommended approval. Jonathan moved for approval of the landscaping and recommended the return of the deposit. Flo seconded the motion. All voted in favor.

## 5) Report of Officer

- a) Secretary Treasurer
  - i) Delinquent HOA Dues Report

The board thanked GTPM for their work on reducing the amount of delinquent dues.

ii) Financial Review

After review of the financial report, there were no additional questions. The operating account currently has \$57,400 and the maintenance reserve account has \$194,097.

## 6) GTPM

GTPM received a call about the need for using HOA resources to mow the open space and was not supportive of it. The owner was advised that the board will be mowing 1/3 of the open space each year in an effort to appease those homeowners who requested mowing. By dividing it in thirds it will reduce the annual expense to the HOA.

## 7) Violations - Violation Log

There were no violations of consequence. The list is much smaller than it is in the summer months. GTPM will extend the violation review to include the storage area as there seem to be quite a few "unauthorized" items in it. An article in the newsletter will be added to remind people of what can be stored in their spaces.

## 8) Old Business

a) Pond Task Force update

An update was not provided prior to the meeting. GTPM will follow up with the committee and ask if would like to attend one of the next two meetings with any recommendations so the budget can be prepared accordingly.

- b) Front Entry Signs and Lighting update
  - Jonathan signed the MOU this morning; once Bob Hammond signs it GTPM will have it recorded with the county. The signs are currently being made and will be installed as soon as they are done.
- c) Planting new trees in open space
  - 11 new trees were planted in the open space along Melody Creek Lane. The adjacent neighbors were pleased with these additions. The HOA will work with Evergreen Tree Care to make sure they are properly irrigated and treated.
- d) Open Space Landscaping Policy Task Force update

  This group is starting to get something together to meet and discuss the open space landscaping policy. There is nothing to report at this time.
- e) Sales Office Task Force update
  - This committee has met several times and is requesting authorization to pay to have the building thoroughly examined and a formal proposal to be created. The board is not supportive of boarding up the windows and doors with plywood for safety and aesthetic concerns. Jonathan moved to

approve the \$780 fee quoted to do the building inspection to determine what is necessary to bring it up to code. Matt seconded the motion and all voted in favor.

f) Irrigation Pump replacement and digital meter discussion
There is nothing new to report on this item. The board would like to explore cheaper options in advance of preparing the 2019 budget.

## 9) New Business

a) Request from Margie Aeckerle to use Chickadee Park one day next summer for a wedding reception The board is not supportive of this use of the HOA common area. They have concerns about the lack of facilities for guests and would suggest that she look at using a county park instead as it is better equipped to handle an event such as a this. Tina will communicate this with Ms. Aeckerle.
