STORAGE AREA

Please note that if you have a storage space, your items must be registered with Grand Teton Property Management. Please submit copies of your current registration of the item, a photo and description. All items you store must fit within your space – please do not overflow into the roadway or someone else's space. Please do not park your item in any open spot – even if there is nothing in it. We have received a lot of calls recently about this problem which creates enormous difficulty for the people trying to park their items in their space. Do not store trash, construction equipment and materials, yard equipment, etc in your space – it is intended to be used for recreational vehicles and trailers only. If you have questions about the storage area, the rules are posted on the website, or feel free to call GTPM.

DID YOU KNOW?

Did you know that the first Thanksgiving celebration lasted three days? It was in 1621 when Pilgrim leader, Governor William Bradford organized the first feast and invited his neighbors, the Wampanoag Indians. Today, Americans eat 46 million turkeys each Thanksgiving – that is 91% of Americans that partake in eating turkey that day. Magazine editor Sarah Josepha Hale, the author of "Mary Had A Little Lamb" lobbied five different Presidents to establish Thanksgiving a national holiday. While every president since Lincoln issued a "Thanksgiving Proclamation" it wasn't declared a National Holiday until 1941 by Franklin D. Roosevelt. Did you know that Ben Franklin thought the turkey was a much more respectable bird and wanted it to be our national bird instead of the eagle which in his opinion had a bad moral character? Another fun fact is that only the male turkeys gobble; the females cackle. While Black Friday, the day after Thanksgiving, is the busiest shopping day of the year, it is the busiest day of the year for plumbers as well, according to Roto-Rooter. RV Storage

Just a quick reminder to those of you with a storage space in the Melody RV lot that there are quite a few homeowners who are still on the waiting list for a spot. Covenant Corner

~ All household and maintenance items such as wheel barrows, ladders, lawn mowers, snow blowers, bins etc. should not be left in open view and should be stored within a closed area such as a garage and/or behind fenced enclosure or "out of sight" from the road and neighboring properties view. This is Tier One Violation, \$25 fine ~ Dogs are to be restrained or leashed within the community at all times. First Violation: If any animals are caught or identified chasing or otherwise harassing livestock, wildlife, people, vehicles or bicycles, the Board shall have the authority to have such animal or animals impounded, and shall assess a penalty against the owner of such animal or animals of \$250.00 plus all costs of impoundment.
