#### **Covenant Corner**

~ Holiday decorations including Christmas lights, wreaths and garland should be removed in a timely manner after the holiday has passed. Christmas lights shall be allowed from Thanksgiving Day until February 15<sup>th</sup>. This is a Tier One, \$25 fine.

~ Exterior Lighting. All exterior lights and light standards on Lots shall be approved by the ARC for harmonious development and the prevention of lighting nuisances to other lands in the Subdivision. This is a Tier One, \$25 fine.
