#### 1) Homeowners & Guest Time

~ Pond Task Force, Task Force Members Steven Smith and Warren Myers

The pond committee has been working with the Teton County Conservation District (TCCD) on assessing the current pond conditions and how to improve the quality of the water, the aesthetics of the ponds and the ecological impacts of them. The pond committee would like to balance the water flow and quality with the obligations to communities downstream. There are several options available and the task force is investigating these. The introduction of other riparian vegetation around the ponds (including willows, bull rushes and grasses) could help minimize the amount of algae in the ponds and increase the presence of wildlife. There are grants available through the TCCD for water quality and habitat developments to balance aeration and vegetation in the ponds. Melody Ranch is recognized as a potential model for other ponds in the valley and they would like to work with the HOA to improve them. The committee would like to recommend that GTPM continue its efforts in maintaining the ditches and head gates and continue to clear out vegetation and or silt that may restrict the water flow through the ditches in Melody Ranch. There will likely be a phased approach to the pond work to include lining Pond 5 and several of the ditches that flow between the ponds in Melody Ranch. Additionally, the committee would propose a "Pond Improvement Day" in the community where neighbors can be active in plantings and cuttings around the ponds. This would be done in an effort to reduce the labor expense of hiring the work to be done and would foster education and awareness of homeowners about pond ecology and pond management. It was suggested that the pond task force grade or rate each pond in order to prioritize them. The board would like to get an idea of a budgetary place mark for the next meeting for the initial phase of work.

The Sales Office committee has been working with the Teton County Preservation Board (TCPB) who has provided them with information and helpful resources in their work. They have an interest in the history of the building as it was originally built in Grand Teton National Park on the banks of Jackson

Lake. They would like to look further into that history. April Norton from Teton County is also looking at the building from the perspective of repurposing it as affordable housing. She will look at it with the task force later in the week. It is currently zoned for recreational open space. It has recently been vandalized again as the door was kicked in and a window was smashed. These have been repaired and boarded up for the time being until such time that something can be decided about the future of the building. The opinions of neighbors are greatly varied and it is the goal of the task force to discover the best use and value for the building, knowing that it will not satisfy everyone. It is currently a growing liability. There will be a report available for the annual meeting. In the meantime, the task force would ask for \$2,500 to be placed in the budget for incidental expenses for 2019.

The board agreed to put an article in the newsletter to advise people of the situation and to remind everyone that this is an animal control issue. Should there be an incident of a dog bite, attack or being off-leash homeowners are asked to report it to animal control as they are trained and skilled to handle these matters.
