PATHWAYS REMINDERS

Neighbors, there have been a lot of issues regarding the County pathways that run through Melody Ranch. We wanted to remind you of the county rules about what is and is not permitted to be used on the pathways throughout Teton County (and Melody Ranch).

- OKAY ON PATHWAYS
 - Bicycles
 - Skateboards, rollerblades, scooters (non-motorized)
 - Also, "Motorized toy scooters and skateboards designed for children are allowed on pathways owned and/or maintained by Teton County in the unincorporated areas of Teton County, but may only be ridden by children 14 years old and younger"
 - E-bikes (Class 1, 2, and 3)

 - Motorized wheelchairs or "personal assistive mobility devices"
 - DEFINITELY **NOT** ALLOWED ON PATHWAYS
 - Anything with an internal combustion engine
 - o Golf carts
 - o Segways
 - Mopeds, motorcycles
 - o Snowmobiles
 - E-bikes that do not meet the Class 1, 2, or 3 "low-speed electric bicycle" classification
 - Note: the prohibition on motorized use does not apply to authorized maintenance or emergency vehicles

WEED SPRAYING

There have been a lot of questions about the spraying of noxious weeds this summer and we wanted to share some information with you. GTPM has previously distributed an herbicide rate chart for your reference which included the more popular and commonly used herbicides. This information was provided to us from Teton County Weed and Pest. We have found them to be extremely helpful and knowledgeable regarding concerns raised about weed spraying. If you have additional questions or want to know more information, they are happy to talk to you directly about the various options for weed abatement, the rules, laws and requirements about what needs to be treated, the dangers of not treating specific weeds the right way, the potential side effects of some herbicides and so much more. Covenant Corner

~ Noxious and Offensive Activities. No noxious or offensive activity shall be carried on upon any Lot, nor shall anything be done or placed thereon which may be or become a nuisance, or cause unreasonable embarrassment, disturbance or annoyance to other Owners in the enjoyment of their Lots, or in their enjoyment of common areas. This is Tier Two Violation, \$100 fine.

~ Trash receptacles are to be placed at the edge of driveways only on the designated trash day. Once trash has been picked up, these receptacles must be removed from driveways within 24 hours. When not on the street for trash pick-up, all trash receptacles are to be stored in the garage or "out of sight" behind a fence enclosure. All trash must be kept in bins at all times. Bags of trash or other household items being disposed of are never to be left outside bins. Accumulation of garbage and/or building material or of the like constitutes a nuisance, and may be removed by the Association at the owner's expense. This is a Tier One Violation, \$25 fine.

***Please refrain from leaving piles of "free" items on the side of the road as it is considered a nuisance and trash. It should be disposed of promptly.
