2) Executive Session

An executive session was not required.

3) Approval of January 21, 2020 board minutes

Jonathan moved to approve the minutes from 1/21/20. Matt seconded the motion, and all voted in favor.

4) ARC Reviews

a) Paul, 4335 Melody Ranch Dr. 2-031, Final review

Jonathan reviewed the plans as well as the DRC discussion and recommendation to approve this new home to be built as presented. Flo moved to approve the plans. Michael seconded the motion, all voted in favor.

- ** In an email discussion Jonathan moved on 4/3/20 to approve the request of Jim Miller on Sandy Creek to remove three trees from his backyard. (The LRC met with the homeowner on site to confirm the trees and their locations and made the recommendation to approve the request). Michael seconded the motion, and all voted in favor by email.
- ** In an email discussion, Jonathan moved on 4/18/20 to approve the request of George and Sheila Poore on 4080 Sandy Creek to remove six trees from their yard. (The LRC met with the homeowners on site to confirm the location of the trees and made the recommendation to approve the request). Michael seconded the motion, and all voted in favor by email with Flo absent from the vote.

5) Report of Officer

- a) Secretary Treasurer
 - i) Delinquent HOA Dues Report

There aren't many owners on the delinquent list. Tina noted that she would reach out to the most delinquent on the list and urge them to make a payment. If payment has not been

received by the next meeting a lien will be filed at the expense of the owner.

ii) Financial Review

There is not a lot to review in the 2020 fiscal year. Income is above the budgeted expectation and expenses are below it but only being a month into the year, that is expected. The board discussed and voted to move \$50,000 from the operating account into the maintenance reserve account. GTPM will look into current 1-year CD rates for First Interstate Bank as well as the Bank of Jackson Hole. In order to maintain FDIC coverage, the board would like to be sure the reserve funds are protected and the HOA can earn more income from the interest of a CD as opposed to a savings account.

** In early April Todd opened an 11-month CD for the HOA in the amount of \$200,000. He secured a rate of 1.09%

There are some funds in the landscape deposit account. The board would like to take a better look at who has money in the account, what can be done to return the deposit, or if the homeowner is forfeiting the deposit for one reason or another. GTPM will audit this account and report back to the board.

iii) 2020 Draft Budget Review

With the expectation that more interest will be earned in the CD, the budget which will be presented at the annual meeting will include that expected income as well as an increase in the ski track grooming expense. The entry sign improvements and entry sign maintenance line items will be switched.

6) GTPM

The entry sign that was run into at the beginning of winter is being stored by GTPM. The board would like the sign to be repaired and then reinstalled when the ground thaws later this spring. There will be more conversation about the placement of the sign and how to manage it when the roads get slick at a later time.

8) New Business

a) Review Agenda for Annual Meeting

Jonathan has asked the pond committee as well as the old sales office committee to address the owners at the annual meeting and answer questions that may arise.
