### VALVE REPAIR

The Melody ISD has hired a contractor to do preventive maintenance on water valves. The east side of Melody Ranch has had valve failures in the past due to corrosive soils causing bolts to fail on the water valves. This work will replace bolts on some valves, before they fail, with bolts that will last. Work has begun; please expect minor disruptions in water service as each valve is taken out of service. Water shut offs may and will occur any time during the workday. In general, they should not last more than a couple hours. All water service will be restored at the end of each workday unless a major problem is encountered. In the event of a longer water interruption, we will be in contact with the homeowners that will be affected. Expect equipment working on or near the roads. Temporary pumping is needed to remove groundwater when working on the valves. You may see hoses routed across streets and through yards to discharge this groundwater. Please reduce your driving speed when driving over the hoses. Any pavement will be patched later in the spring.

## DOG REMINDERS

We have been receiving an increased amount of phone calls regarding dogs being loose and running through the yards, streets and open spaces of Melody Ranch. While it may be easier to open the door to let your dog outside, please remember that not only is this a violation of the Melody Ranch governing documents, but it is also a dangerous situation for your dog, children, pedestrians and other animals. **Your dogs must be restrained at all times**.

The CC&Rs state: "Dogs and other domestic animals shall be controlled and restrained at all times and shall not be allowed to run at large on any portion of any Lot, except within an enclosed improvement area."

Furthermore, when a dog is let loose to run, there is nobody there to clean up after it or control it around cars, people and animals. Any dog seen running loose without an owner is subject to a fine and animal control will be notified to pick up the dog. Homeowners, please feel free to contact the dog catcher at 733-2331 if you see a roaming dog, a dog that is a nuisance or if a dog is aggressive. Remember, the penalty for pet violations begins at \$250 plus the costs of any necessary impoundments. This is for the safety of your animal and for the community as a whole.

### TEST WELL DRILLING

The Melody ISD will be having another test well drilled starting the March 28, 2022. The location is near Melody Creek Lane. This is a third attempt to find a water source for a third well that will ensure quality water for the neighborhood into the future. This should not interfere with traffic and drilling is only during the day for a couple of weeks.

### WEED SPRAYING

If you own a vacant lot and would like to be responsible for spraying your noxious weeds this year, please notify Charley at Grand Teton Property Management. If you opt to have the HOA do your spraying, the cost will be \$75 per application and it is done twice over the summer. If we do not hear from you by April 15<sup>th</sup>, we will assume you want us to spray and you will see the charges on your monthly statement.

~ Trailers, boats, RV's, and inoperable vehicles of any kind are not permitted to be parked in driveways, in yards or on the street at any time. These may be stored on properties as so that they are never visible by neighboring properties, i.e.: in garages. This is Tier Two Violation, \$100 fine.

~ No buildings, structures, or improvements of any nature shall be placed, erected altered, or permitted to remain on any recreational open space area. This includes but not limited to the following: fencing (real or invisible), private landscaping (except with ARC prior approval), trampolines, storage sheds, etc. This is a Tier Three Violation, \$250 fine.
