Please Slow Down!

There have been numerous complaints about people speeding within the community. Please remember the speed limit is 15 mph, whether in a car or on an ebike. Please remind your contractors to keep their speed down to 15 mph. Together we can keep Melody Ranch safe for everyone.

Covenant Corner

~ All vehicles shall be parked in designated parking spaces on the lot or the spaces provided therefore on multiple dwelling lots. No more than two vehicles may be parked in driveways for extended periods of time. No vehicle may be parked on any street within Melody Ranch or on any yard or common area on individual or multiple dwelling unit lots. This is Tier Two Violation, \$100 fine

~ There shall be **no exterior fires** whatsoever except barbecue fires contained within designated receptacles, i.e.: grills. This is a Tier Four Violation, \$300 fine plus applicable legal fees.

~ Trailers, boats, RV's and inoperable vehicles of any kind are not permitted to be parked in driveways, in yards or on the street at any time. These may be stored on properties as so that they are never visible by neighboring properties, i.e.: in garages. This is a Tier Two Violation, \$100 fine.

ISD Water Billing Change

The ISD Budget Hearing was held on July 11, 2024. While property taxes will once again remain the same, water use rates were increased effective July 1, 2024. The water use billing system will remain a tiered structure so there is incentive to conserve water where possible. Please note that water use pays for the operation and maintenance of the system and are not applied to capital improvements.

The new billing is as follows:

BASE FEE: \$5.00 (no change) - Billed each month for each home connected to the system.

Tier 1: Rate increase from \$2.10 to \$2.50 - For every 1000 gallons used below 60,000 gallons.

Tier 2: Rate increase from \$3.00 to \$3.60 - For every 1000 gallons used at or above 60,000 gallons.

Typically, your water bill will be in Tier 1, unless you use a lot of water for irrigation. Please check your sprinkler systems and adjust watering based on temperature and rain. As trees and bushes mature, they need less watering than one newly planted. Small leaks inside and outside the home add up to a lot of wasted water.

The ISD Board thanks you for your efforts in water conservation. The water savings have been measurable over the past year.

Gone To The Dogs

There have been several dogs running loose in the neighborhood. PLEASE make sure to keep your dog on leash to avoid other people or animals being attacked and injured. In the event of an incident or loose dog, please call animal control.

School Days

Residents, please be aware that it is time for the kids to head back to school. The first day of school is right around the corner. With that in mind, please be alert, and keep your eyes open in the morning and afternoon as kids head to and from school and the bus stop. Drive slowly – the speed limit in Melody Ranch is 15 mph.

If you are dropping your child off at the bus stop, please do not park on the grass or in the open space while you wait. Remember to be patient and courteous during these busy moments of the day. Let's all work together to keep the smallest residents of our neighborhood safe.
